IRFAN SAADAT KHAN, J:- The instant Constitutional Petition has been filed with

- 1. To declare that Disabled Persons are equally respectable citizens and entitled to enjoy all constitutional fundamental rights without distinction, discrimination or exception and are also entitled to the right to enjoy a decent life, as normal and full as possible, besides, the right of freedom of movement and access to public places.
- 2. To direct the Respondents that height of Public footpaths and Ramps /Slopes on either sides thereof are constructed in Cities & Towns in accordance with the specifications of international cities, in a manner to facilitate its convenient use by walkers, by wheelchair users and by those who use pushing prams or pushchairs.
- 3. To direct the Respondents to ensure that Ramp-facility is provided parallel to the stairs at all Public-use Buildings, Offices, Markets, Shopping-Centers, Educational Institutions, Hotels, Parks; including Cinema & Theaters etc. in Karachi and other Cities / Towns of this Province.
- 4. To grant any other relief, which this Hon'ble Court deems fit and proper under the circumstances of the case.

2. This petition has been filed as a public interest litigation, whereby it is prayed that since the disable, weak and ailing persons use wheelchairs, hence, instructions

may be issued to the respondents to make sure that in the markets /shopping centers,

mosques and educational institutions proper arrangement is made to enable the said

persons to have access for these areas. Notices thereafter were issued to the

respondents and in response whereof the respondent No.2 filed his comments

wherein it has categorically been stated as under:

"It is ensured that in future during preparation of estimates for work of construction of footpaths, the provision of ramps at difference places will be incorporated in the interest of smooth mobilization of disable and weak

persons".

In view of the above comments filed by the respondent No.2, we dispose of this petition by observing that proper legislation in this regard is imperative to

facilitate these disable, weak and ailing persons using wheelchairs to have access and

a free movement on the footpaths, in public places, markets, shopping centers,

mosques, educational institutions, etc. We, therefore, direct the respondent No.1 to

prepare a summary and refer the matter to the Chief Minister Sindh for making

proper legislation in this regard to facilitate the disable and other persons. We also

expect from the Chief Minister Sindh that he would make efforts for making proper

legislation within a period of three months. We also direct the respondents No.2 & 3

to issue instructions to the concerned departments and concerned authorities for

making provision of ramp for smooth mobilization of these persons. Petition stands

disposed of in the above terms along with the listed application.
