Learned counsel for the petitioner submits that various FIRs are lodged by the petitioner party against the illegal acts of the accused persons named in the Petition but they are not being arrested by the respondent Police officials though they are available in their villages. He further submits that the challans in all such cases have been submitted by the Police and same are lying pending before the concerned Courts due to absconsion of many accused persons involved in such cases and, therefore, the petitioner needs protection from the harassment.

Learned AAG waives notice and submits that this Petition can conveniently be disposed today without further notice or hearing as the protection of law is the fundamental right of the petitioner.

It appears that some of the cases registered by the petitioner party are pending in the Courts, situated within the territorial jurisdiction of Circuit Courts, Larkana and Hyderabad.

## ORDER SHEET

### **HIGH COURT OF SINDH BENCH AT SUKKUR**

In view of above, this Petition is hereby disposed of with direction to the trial Courts, located within the territorial jurisdiction of this Bench, to take action against the absconding accused in accordance with law, while the respondents Nos. 2 to 6 are directed to provide due protection of law from the alleged harassment, if any, <sup>to the petitioner</sup> and if any action is taken in the matters of the parties, the same should be in accordance with law and not in contravention of any law. So far as the cases, pending in the Courts falling within the jurisdiction of Circuit Courts, Larkana and Hyderabad are concerned, the petitioner is at liberty to approach there for appropriate remedy.
