The petitioner has impugned the posting of respondent No.3 as Assistant Engineer in Highway Sub-Division, Khangarh District Ghotki.

At the very out-set learned counsel for the petitioner was confronted with Article 199 of the Constitution of the Islamic Republic of Pakistan, 1973, and directed to show whether the petitioner is an aggrieved person in terms of above Article, he very candidly conceded that neither the petitioner is employee of Highway Department nor has any nexus with the affairs of Highway Sub-Division Khangarh but his grievance is that since the respondent No.3 is Sub-Engineer, therefore he cannot hold the additional charge of vacant post of Assistant Engineer Highway Sub-Division, Khangarh.

Since the petitioner is not an aggrieved person in terms of Article 199 of the Constitution, therefore, we are of the considered view that the petitioner has no locus standi to invoke the extra ordinary constitutional jurisdiction of this Court; hence the instant petition being devoid of merits, is dismissed alongwith listed applications. However, Secretary, Works & Services Department, Government of Sindh, is directed to ensure that no officer shall be posted
