With reference to order dated 28.9.2021, all the twenty-seven (27) cases which were recommended for disposal in "C" class have already been so disposed of by Anti-Terrorism Court No.XV, Karachi, which is evident from the progress report filed by SSP Investigation-II, East Zone, Karachi, which is taken on record.

On the last date of hearing, it was noted that only three (03) FIRs remained in the field. Vide report of SSP Investigation-II, East Zone, Karachi, out of them, FIR No.257/2021 has been disposed of under "A" class.

Thus, only two FIRs remained in the filed which both have been challaned and in that FIR 108 accused persons have been released.

In FIR No.258/2021, fifty-five (55) accused persons have been sent up to face trial out of whom only six (06) are in custody. FIR No.259/2021 has also been challaned and again fifty-five (55) accused persons have been sent up to face trial and out of them only six (06) accused persons are in custody. It is noted that in both the challans, six accused persons are same who are in custody. The accused persons who are in custody may seek bail before the concerned trial Court or may make any other application in accordance with law.

It is noted that both the FIRs relate to Bahria Town incident, which took place on the same day, as such, the learned trial Court based on particular facts and circumstances of this case shall consider the amalgamation of both the proceedings and holding of one joint trial.

The petitioners state that the issue of more than one FIR registered in respect of same incident, is still alive, as two FIRs arising out of same incident in field. They however, state that they would be satisfied if they make application regarding quashment of either or both of these FIRs/ proceedings and their such applications are disposed of expeditiously by the concerned trial Court. Order accordingly. A copy of this order shall be sent to the learned Anti-Terrorism Court No.XV, Karachi.

All these petitions are disposed of in the above terms. A copy of this order shall be placed in each petition.
