**ORDER**

**Amjad Ali Sahito, J:-** Through this Cr. Misc Application, applicant Mst. Zubaida is seeking recovery of detainees namely Mst. Reshman, Mst. Amina & minor Murtaza. After filing of this Cr. Misc Application, notices were issued to the official respondents, who had submitted their reports respectively.

2. On 27.03.2025 in compliance of Court’s order, Inspector / SHO PS Daur Saeed Ahmed Channa produced detainee Mst. Reshman, however, it was also disclosed that a beheaded body of a woman has been recovered and such FIR bearing crime No.09 of 2025 U/s 302 & 201-PPC has been lodged at PS Jam Datar District Shaheed Benazirabad on behalf of State.

3. The officials present in the Court have disclosed that Mst. Amina (detenue No.2) had contracted free will marriage with Muhammad Urs in 2016 and out of such wedlock, they had one issue namely Murtaza (detenue No.3). Police officials present further disclosed that the DNA of beheaded body of a woman was collected, which have been matched with Mst. Shahzadi, who is the mother of deceased Amina. It has further been informed that minor Murtaza has also been murdered, however, such investigation is still being carried out in crime No.09 of 2025, wherein four accused persons namely Rahim Bux Jatoi, Hussain Bux Jatoi, Imdad Jatoi & Ali Hyder Brohi

are arrested, while raids are being conducted for arrest of other co-accused to bring out the actual facts of the case.

4. Since, one detenue has been recovered, while for another two detenues FIR has already been lodged on behalf of the State, wherein an investigation is also being carried out, therefore, at this stage the instant Cr. Misc Application has become infructuous, resultantly, the same is hereby **disposed of**. However, applicant is at liberty to approach the concerned Trial Court to pursue crime No.09 of 2025 of PS Jam Datar, District Shaheed Benazirabad.
