It seems to be the case that there is a dispute between the parties over a matrimonial affair. Prior to this application Mst Alisha filed the application under section 22A&B Cr.P.C, wherein it is mentioned that Hidayatullah has contracted marriage with Mst Alisha daughter of Muhammad and such protection was obtained by the respondent No.3 from the Court Additional Sessions Judge-I/Ex-Officio Justice of Peace, Mirpurkhas. During marriage it was suffice that that the parties have compromised and subsequently per learned counsel Hidayatullah pronounced Talaq/Divorce to Mst Alisha. After passage of time Mst Alisha started to reside with respondent No.3/Hidayatullah. As such the applicant has failed to made out the case for registration of FIR against the respondent No.3 & 4, who are claiming that they are husband and wife and have not committed Zinah.

In view of the above there is no illegality or material irregularity in order passed by the court below, hence instant Criminal Miscellaneous Application is hereby dismissed.
