Petitioner is present in person and submits that about two years back, the official respondents No.3 to 7, who are working in Police Department as Police Constables, had committed theft from his house forcibly. Petitioner next submits that for the return of the said theft property he had filed Direct Complaint against aforesaid official respondents before the Judicial Magistrate-I, Shahdadt, which is pending adjudication. Petitioner further submits that the official respondents time and again are causing harassment with a view to withdraw from the Direct Complaint filed against them. Petitioner further submits that three days back respondents No.1 & 2, SHO PS A-Section Shahdadt and SHO PS B-Section Shahdadt respectively called him at their respective Police Stations to settle the matter with respondents No.3 to 7, otherwise he will be booked in the series of false criminal cases along with his family members. Petitioner further submits that he has approached to respondents No.8 for redressal of his grievance but he being in league with respondents No.3 to 7 has not heard him rather has threatened him to meet with unjustified demands of respondents, otherwise the petitioner shall have to face dire consequences.

Be that as it may, whereas, District Complaint Officer for ~~SS~~  
each District comprising of Superintendent of Police has been  
nominated by the Government and police complaint redressal  
mechanism as per recommendations of the Police Reforms Committee,  
has been operationalized at district level in all over Pakistan which is  
headed by Superintendent of Police, Complaint Cell.

Therefore, office is directed to send copy of the order along  
with memo of petition and annexures therewith to Superintendent of  
Police, Complaint Cell, Kamber Shahdadt Kot at Kamber for the redressal  
of the grievance of the petitioner; the petitioner is also required to  
agitate his grievance over there. The Superintendent of Police,  
Complaint Cell, upon receipt of copy of this order may call the parties  
and after hearing to either side shall decide the issue in writing  
preferably within three weeks. Copy of order be faxed today to  
Superintendent of Police, Complaint Cell, Kamber Shahdadt Kot at  
Kamber, through SSP Kamber Shahdadt Kot, for compliance.

Besides, there are allegation(s) of malfeasance and  
misfeasance against the official respondents hence Superintendent of  
Police, Complaint Cell shall conduct probe and report within three  
weeks positively. Needless to mention that no harassment shall be  
caused to the petitioner and his family, besides police shall act strictly  
in accordance with law.

The copy of order may also be faxed to Inspector General of  
Police Sindh, Karachi for compliance.

Petition stands disposed of in the above terms.
