In compliance with the order dated 01.12.2025, the Chief Secretary, Government of Sindh, has filed a compliance report, which reflects that the Government of Sindh has released a substantial amount of funds and has also acquired the land for the construction of M-6 (Motorway), following details whereof have been placed on record.

We are, however, shocked to observe that despite the release of such a colossal amount by the Government of Sindh, not even a single

stone has been laid at the site of **M-6 (Motorway)**. Under these circumstances, the conduct of the National Highway Authority (NHA) appears to be highly questionable. **The Chief Secretary, Government of Sindh, is also directed to explain as to under which provision of law such amount has been released to the Government of Pakistan for the construction of M-6 (Motorway).**

Today, none has appeared on behalf of the NHA, nor has any compliance report been furnished, despite the fact that on the last date of hearing, in the presence of representatives of the NHA and the Joint Secretary, Ministry of Communications, Government of Pakistan, directions were issued to the Secretary, Ministry of Communications, Government of Pakistan, to place on record details of toll plazas established throughout Sindh, the names of the persons authorized to oversee the collection of toll taxes in Sindh, and the amounts recovered on a daily basis from each toll plaza during the preceding one year. However, no such compliance has been made. **In these circumstances, let show-cause notice be issued to the Secretary, Ministry of Communications, Government of Pakistan, to explain as to why contempt proceedings should not be initiated against him.**

The Secretaries, Regional Transport Authority, Sukkur and Khairpur, have also filed their respective statements. We are not satisfied with the same. Learned AAG has further filed statements on behalf of DIGP, Sukkur Range, SSP, Sukkur, SSP, Khairpur, and SHO, Police Station Ranipur; however, the said statements are vague in nature and do not address the issues raised by this Court. We have been informed that earlier, pursuant to the directions of this Court, barriers were installed on Mehran Highways; however, during the last week, the said barriers have been removed and heavy vehicles are again being allowed to ply on the said road. In such circumstances, **let show-cause notices be issued to SSPs, Khairpur and Naushahro Feroze, to explain as to why contempt of Court proceedings should not be initiated against them.**

It is further noted that SSP, Sukkur, has failed to place on record the details and figures of FIRs registered against traffic police officials and NHA officials in respect of untoward accidents or incidents, despite specific directions of this Court. Under such circumstances, **let show-cause notice be issued to SSP, Sukkur, to explain as to why**

contempt of Court proceedings should not be initiated against him.
