The order dated 22.01.2026, passed in C.P.No.D-52/2026, C.P.No.D-54/2026 and C.P.No.D-432/2025, which are similar petitions, is as follows:-

All these Petitioners seek employment in Government service on the quota reserved for disabled persons under the Sindh Empowerment of Persons with Disabilities Act, 2018 and Sindh Civil Servants Act, 1973. The Sindh Act of 2018, which is the special law on the subject, provides *inter alia*:

- “11.(9) Authority shall establish a ‘Special Employment Exchange and portal’, to which every establishment shall furnish such information as maybe prescribed by the Government in relation to vacancies earmarked for “Persons with Disabilities” which have occurred and filled or are about to occur.
- 11.(11) The Grievance Redressal Officer shall maintain a register of complaints in the manner as maybe prescribed by the Authority, and every complaint shall be inquired within two weeks of its registration. If the aggrieved persons is not satisfied with the action taken on his/her complaint, he or she may approach the Authority.
- 11.(12) The Government shall reserve a quota of five percent (5%) at various levels for the ‘Persons with Disabilities’ in the Government departments, institutions, entities, and corporate entities owned and managed by the Government. The Government shall through notification provide for such relaxation upper age limit for employment of persons with disabilities as it thinks fit.”

Furthermore, Section 28 of the Sindh Act of 2018 established an Authority, namely the Sindh Persons with Disabilities Protection Authority (SPDPA), for implementing and enforcing the provisions of said Act. It appears to us that if aforesaid provisions are implemented in letter and spirit, grievance of most of such Petitioners can be redressed at the departmental level. Therefore, Learned AAG Sindh shall take instructions and inform the Court whether the SPDPA is functional, and if so, whether the Special Employment Exchange and Portal envisaged in Section 11(9) of the Act has been deployed to facilitate employment of disabled persons. The Sindh Persons with Disabilities Protection Authority (SPDPA) is a necessary party to these

petitions. It is therefore added as a Respondent. Learned counsel for Petitioners shall file an amended title accordingly. Thereafter, notice be issued to the SPDPA through its Director General or Regional Director, At Larkana.

The aforesaid order is passed in these petitions.

The petitioners shall file amended title to array Sindh Persons with Disabilities Protection Authority (SPDPA) as the respondents in these petitions, where-after the notices be issued to said authority.

Pursuant to order dated 22.01.2026, Mohsin Raza, Additional Deputy Commissioner-II, Larkana, on behalf of Deputy Commissioner, Larkana, states to the best of his knowledge that the Authority (SPDPA) envisaged in Section 28 of the Sindh Act, 2018, has not been notified. Learned Additional Advocate General, Sindh, seeks time to seek instructions in that regard from the Chief Secretary, Sindh, and to file the comments in that regard.

The comments on behalf on behalf of Chief Secretary, Sindh, shall also apprise the Court of steps taken to implement the Provisions of Section 11 of the Sindh Act, 2018, particularly Sub Section 9 and 10 thereof (reproduced in order dated 22.01.2026).
