Mr. Mohammad Afzal Jagirani by holding brief on behalf of Mr. Ashfaq Hussain Abro, advocate for the applicant, submits that name of the applicant does not transpire in the FIR, however, upon the further statement dated 16.1.2019 recorded by the I.O., the complainant has implicated him and therefore, upon the basis of said document, which, according to him, is not permissible under the law, have been bent upon to arrest him for some ulterior motives. He next submits that applicant attempted to appear before the concerned Court/trial Court for seeking remedy in shape of pre-arrest bail as required by Section 498, 498-a, Cr.P.C, but the police in collusion with the complainant of the case have cordoned all the ways leading towards the trial Court, therefore, he has not surrendered before the concerned Court. He also submits that the applicant is retired government servant as Tapedar and in case he is arrested, he will be subjected to maltreatment and humiliation at the hands of police, besides, his dignity, honour and prestige will be damaged/spoiled.



Without touching merits or demerits of the case, applicant is admitted to protective pre-arrest bail for 10 days from today in Crime No.05/2019 of Police Station Lakhi Gate, Shikarpur, registered under Sections 384, 506/2, PPC read with Section 6/7 of Anti-Terrorism Act, 1997, subject to his furnishing solvent surety in the sum of Rs.50,000/- and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court.


