

1. Urgency application granted.

2. Through instant application, applicant/ surety Kifayat Hussain seeks return of surety documents on the plea that he stood surety for accused Zaid alias Ghulam Mustafa Shah, 2. Saddam Hussain Shah, 3. Iqram Ali Kehar and 4. Lakhmir Khan Kehar, who were granted protective bail for seven (7) days in Crime No.04/2022 of P.S Mahota vide Order dated 19.5.2022, thereafter they surrendered before the concerned Court and have been admitted to interim pre-arrest bail. The applicant / surety has placed on record a copy of letter of learned Court below showing surrender of accused and grant of interim pre arrest bail.
