1. Urgency is allowed.

2. & 3. Through this Application, applicant/surety submits that applicant/ accused Athar Ali Soomro was granted interim pre-arrest bail in Crime No. 34/2024, under Sections 121-A, 123-A, 124-A, 131, 153-A, 11-A, 341, 427, 353, 6/2-N, 6(2)(C) ATA, registered with P.S Market. He next submits that in compliance of said order, applicant/surety Rahib Ali stood surety on behalf of accused by depositing Special Savings Certificate No. HF-088023, vide Registration No.74684, dated 20.03.2024, issued by National Savings Centre-I, Larkana. After furnishing surety, applicant/accused surrendered before the trial Court/Judge, Anti-Terrorism, Larkana, wherefrom his interim pre-arrest bail has been confirmed vide order dated 02.04.2024.
