Meanwhile, operation of NBWs issued against the applicant by the trial Court in the above crime shall also remain suspended for seven days.

This protective bail granting order shall cease to operate on expiry of 07 days from today i.e. on 25.02.2024 or any earlier date when the applicant surrenders himself before the Court concerned, whichever is earlier.

Instant bail application stands disposed of in above terms.
