This protective bail granting order shall cease to operate on expiry of 05 days from today or such earlier date when the applicants surrender themselves before the Court concerned, whichever is earlier. Meanwhile, operation of NBWs, if issued by the learned trial Court against the applicants, shall remain suspended during intervening period.

Bail application stands disposed of in above terms.

1. Urgency application is granted.
2. It appears that protective bail was granted to the applicants Illahi Bux, Zulfiqar Ali, Ali Gul & Ali Gohar @ Shahbaz in Crime No.118/2019 of Police Station Saddar Jacobabad, under sections 148, 149, 302, 311, PPC by this Court vide order dated 24.11.2023 in the sum of Rs.50,000/- each and P.R bonds in the like amount. According to the report of Additional Registrar, surety was furnished by the applicant by producing Special Savings Certificate, issued by National Savings Centre-I, Larkana. After furnishing surety before this Court, the accused surrendered before the Court concerned vide Crl. Bail Appln. No.1100/2023, where they were granted pre arrest bail by way of order dated 14.12.2023. Hence purpose of surety bond stands served, therefore, submits that surety amount is no longer required by this Court; hence seeks its release/withdrawal.

Learned Addl. P.G after going through the record submits that the surety papers are no more required by this Court, therefore, he does not oppose the application for return of surety.

Accordingly, application for return of surety is allowed. Office is directed to return the surety documents viz. Special Savings Certificate to the surety after proper verification, identification and as per rules.
