- 2&4. Through this constitutional petition, the petitioner, *Shah Zaib Akhtar S/o Mian Pervez Akhtar*, seeks protective-cum-transitory bail in FIR No. 11/2021 registered with P.S. FIA, CBC, Karachi under Sections 406, 409, 468, 471, and 109 PPC.

Learned counsel for the petitioner submits that the petitioner is innocent and has been falsely implicated in the present case. He contends that the petitioner, being a law-abiding citizen, is unable to approach the Court for seeking bail and apprehends his *mala fide* arrest at the hands of the FIA. He further submits that the petitioner is presently in the UAE and intends to return to Pakistan on 29.04.2026; his air ticket is available at page 107 of the Court file. He adds that the petitioner has been declared a proclaimed offender, as a consequence of which his CNIC has been blocked.

Without touching merits of the case, protective-cum-transitory bail for a period of fifteen (15) days (from 28.04.2026 to 12.05.2025) is granted to the petitioner above named subject to furnishing solvent surety in the sum of Rs.100,000/- (Rupees one lac only) and P.R bond in the like amount to the satisfaction of the Nazir of this Court. Petitioner is directed to surrender before the trial Court concerned in the aforesaid period and join the investigation/trial forthwith. This order shall cease to have its effect after expiry of fifteen (15) days from 28.04.2026 to 12.05.2026 or the

petitioner surrenders before the trial Court in the aforesaid period, whichever is earlier. His bail bond shall stand automatically forfeited.

In the meanwhile, operation of the perpetual NBWs issued in respect of aforesaid crime against the petitioner shall remain suspended during the aforesaid period and Respondent No.4 (The Director, Regional Head Office, NADRA, Karachi) is directed to unblock CNIC of the petitioner bearing No.42301-5379087-9 for the aforesaid period.

Let a copy of this order be sent to the Secretary, Ministry of Interior, Government of Pakistan as well as Respondent No.4 by fax for compliance.

The instant petition is accordingly disposed of.
