present and submits that the Applicant Fahad son of Khalil Umar is  
required as an accused in Crime No. 4/2026/EXP/PMBQ registered  
under sections 2(s),15, 16, 32(1), 131 & 209 of the Customs Act, 1969  
read with Clause (e) of para 15 of Export Policy Order further read with  
Drugs Act, 1979, punishable under sections 8, 9, 14 & 44 of Section  
156(1) of the Customs Act, 1969 at Police Station Collectorate of  
Customs (Exports) PMBQ, Karachi

Accordingly, the applicant is granted ten (10) days protective bail  
subject to his furnishing surety in the sum of Rs.10,000/- (ten  
thousand) and P.R Bond in the like amount to the satisfaction of the  
Nazir of the Court. This order shall cease to have its effect on 22.04.2026  
or when the applicant surrenders before the concerned Court whichever  
is earlier.
