Hafiz Shahabuddin Indhar, Director School Education (Elementary, Secondary & Higher Secondary), Sukkur Region, Sukkur, is present and has filed two statements, which are taken on record. In the first statement, he submits that, in compliance with the order dated 14.05.2026 passed by this Court, committees were constituted for inspection and audit of the equipment provided to schools, including physical verification thereof, its entry in the respective Dead Stock Registers and verification of its proper custody and maintenance. He further submits that partial audit/inspection reports have been received, whereas the remaining inspection and audit work is in progress and the concerned officers/committees have been directed to complete the same expeditiously.

In the second statement, he submits that all essential basic facilities have been provided to Government (Boys) Higher Secondary School, Mirpur Mathelo, as well as to other Government Schools under the jurisdiction of Sukkur Region, according to their requirements and available resources, and undertakes that such facilities shall be maintained continuously. He further submits that the School-Specific Budget (SSB) has been allocated and disbursed to all schools of the region and undertakes that the same shall be utilized strictly for the betterment of the schools, particularly for provision, maintenance and improvement of basic facilities and other essential operational needs.

Learned counsel for the petitioner, after perusing the statements, submits that he is satisfied therewith and seeks disposal of the instant petition.

In view of the statements and undertakings made by the Director School Education (Elementary, Secondary & Higher Secondary), Sukkur Region, Sukkur, the petition is **disposed of in the above terms**. The statements/undertakings submitted before this Court shall form part of the record and shall remain binding upon the concerned respondents. In case of any violation or non-compliance thereof, the person responsible shall be liable to proceedings in accordance with law.
