Muhammad Saleem Jessar, J.:- Learned counsel submits that petitioner being *sui juris*, without any coercion or force had contracted marriage with one Ahsan Ali son of Gul Hassan and now she is performing her marital obligations and living with her husband with her consent. Learned counsel further submits that relatives more particularly respondents 5 to 9 being antagonized upon marriage of petitioners, are causing threats to the petitioner and her husband moreover, father of petitioner has lodged false FIRs No.159/2026 under section 365-B, 147, 148, 149 read with Section-3 Anti-Rape Act, 2021 and FIR No.235/2026 under Section 324, 354, 186, 224, 225, 147, 148, 149, 337-H(ii) PPC both registered at P.S Sujawal District Sujawal, which are nothing but bundle of lies. Learned counsel for the petitioner prays that above FIRs may be quashed.

2. Learned Assistant Advocate General Sindh and Deputy Prosecutor General, Sindh submitted that official respondents are legally bound to provide legal protection to all citizen including the petitioner and her family members without any discrimination. They after going through the record, ensure that official respondents shall conduct themselves strictly in accordance with law and provide legal protection of life, honour and property to the petitioner and her family members in the manner that no one shall cause them harassment.

3. Learned counsel for the petitioner being satisfied with the statements made by respondents/police officials and learned Assistant Advocate General Sindh and Deputy Prosecutor General Sindh and seeks disposal of instant petition with directions to the official respondents to provide necessary protection to the petitioner and her family members in the manner that no one shall cause them harassment.

4. In view of whatever discussed above, the instant petition stands disposed of with directions to official respondents to conduct themselves strictly in accordance with law and provide necessary legal protection of life, liberty, honour and property to petitioner and her family members in the manner that no one shall cause them harassment. The Investigating Officer of FIR No.159/2026 under section 365-B, 147, 148, 149 read with Section-3 Anti-Rape Act, 2021 and FIR No.235/2026 under Section 324, 354, 186, 224, 225, 147, 148, 149, 337-H(ii) PPC both registered at P.S Sujawal District Sujawal is directed to record the statement of petitioner and then submit such report before the concerned Magistrate and the learned Magistrate will pass appropriate order after considering all the relevant facts, strictly in accordance with law.
