Muhammad Saleem Jessar, J.:- Barrister G.M. Bhutto files Vakalatnama on behalf of Respondents No.7 and 9, which is taken on record. Comments filed on behalf of DSP, Sohrab Goth Division and SHO, P.S SSHIA are taken on record. Learned counsel for the petitioners submits that petitioner No.1 being *sui juris*, without any coercion or force had contracted marriage with petitioner No.2 and now she is performing her marital obligations and living with her husband with her consent. Learned counsel further submits that relatives, more particularly respondent Nos.7 to 10 being antagonized upon marriage of petitioners, are causing threats to the petitioners. Moreover, mother of petitioner has lodged false FIR No.106/2026 under Section 452, 365-B PPC and Section-3 of Prevention of Trafficking in Persons Act, 2018 at P.S A-Section, Ghotki, which is nothing but bundle of lies. Learned counsel for the petitioners prays that above FIR may be quashed.

2. Learned Additional Advocate General Sindh and Deputy Prosecutor General, Sindh submitted that official respondents are legally bound to provide legal protection to all citizen including the petitioners and their family members without any discrimination. They after going through the record, ensure that official respondents shall conduct themselves strictly in accordance with law and provide legal protection of life, honour and property to the petitioners and

their family members in the manner that no one shall cause them harassment.

3. Learned counsel for the petitioners being satisfied with the statements made by respondents/police officials and learned Assistant Advocate General Sindh and Deputy Prosecutor General Sindh and seeks disposal of instant petition with directions to the official respondents to provide necessary protection to the petitioners and their family members in the manner that no one shall cause them harassment.

4. In view of whatever discussed above, the instant petition stands disposed of with directions to official respondents to conduct themselves strictly in accordance with law and provide necessary legal protection of life, liberty, honour and property to petitioners and their family members in the manner that no one shall cause them harassment and they shall not be arrested in the aforesaid FIR. The Investigating Officer of FIR No.106/2026 under Section 452, 365-B PPC and Section-3 of Prevention of Trafficking in Persons Act, 2018 at P.S A-Section, Ghotki is present and submits that he has recorded statement of petitioner No.1 and he will submit such report before the concerned Magistrate. Once such report is submitted before the concerned Magistrate, learned Magistrate will pass appropriate order after considering all the relevant facts, strictly in accordance with law.
