ORDER.

Ahmed Ali M. Sheikh J., Through this petition, petitioner has prayed as under:-

“a). To direct the respondents to return the robbed articles, animals and release the detenues which were taken away by the above named official respondents No. 1 to 4 in collusion with other police officials.

b). That Honourable Court may be pleased to appoint honest 4 ladies to visit the village of petitioner and conduct impartial inquiry against the above named respondents No.1 to 4 in the head of Rangers.

c). To direct the respondents No.1 to 4 not to create any havoc, harassment, humiliate, disgrace, maltreatment, pressurize and issuing threats of involving the villagers and their family members, relatives and well-wishers in false criminal cases which is detrimental of the life, liberty, body reputation or property, except in accordance with law.

d). To direct the respondent No. 5 to take immediate legal action against the official respondents No.1 to 4.

e). To direct the respondents No.1 to 4 to appear in person before this Honourable Court and execute their bonds so that they may not cause any kind of loss to the

petitioner, his family members and other villagers in future.

f). To direct the respondents No.1 to 5 to provide protection to the petitioner, his family members and other villagers.

g). To grant any other equitable relief, as deemed fit by this Honorable Court in circumstances of the case”.

2. From the pleadings, it appears that the petitioner is resident of village Yousif Gujjar, Taluka and district Shaheed Benazir Abad and his grievance is that his relative Sultan Shar has been implicated in false case by local police. Besides above, some innocent persons namely Karam, Fatah, Haji Qabil and some children have been murdered at the hands of Ghotki police. It is further averred by the petitioner that his community is being attacked by the police party and in the entire Katcha area of district Ghotki, a grand police operation has been launched against the innocent villagers.

On query of this court, petitioner replied that though he is resident of district Shaheed Benazir Abad, but he has great concern with life and liberty of his tribe.

We have heard the petitioner in person. Since the bald and vague allegations are leveled against the entire police of district Ghotki without any substance or particular instance; in view of above we are of the considered view that instant petition having no legs is liable to be dismissed at its initial stage following the concept “nipping the evil in the bud before it surfaces”. Consequently, instant is dismissed in limine along with listed applications.
