- Petitioner claims employment in Food Department in terms of Rule 11-A 2. of Sindh Civil Servants (Appointment, Promotions & Transfer), Rules, 1974, as his father, namely, Noor Muhammad was serving in Food Department as Chowkidar and passed away during service on 12.11.2010.
- Pursuant to notice, respondents No. 4 to 6 filed their comments, whereby they have not denied the contents of the petition, however, respondent No.4 has categorically stated in para-5 of his comments that the case of the petitioner has been forwarded to Director, Food Sindh, but till date no order has been received.
- Learned counsel for the petitioner contends that there is no rebuttal on the 4. part of respondents in respect of petitioner's claim in terms of Rule 11-A of Sindh Civil Servants (Appointment, Promotions & Transfer), Rules, 1974. Besides, his case has been forwarded by the concerned authority to high-ups, therefore, instant Rition may be allowed.

Learned Assistant A.G. in view of above, conceded and extended his no ection for the grant of relief, as prayed for by the petitioner.

Admittedly, the petitioner's case is fully covered under Rule 11-A of Civil Servants (Appointment, Promotions & Transfer), Rules, 1974 and thents have already forwarded his case to higher authorities, but till date no

further step has been taken. Besides, during last 4/5 years, number of employees have been appointed in Food Department.

- 7. In view of above, we allow this petition with directions to the respondents
 No. 3&4 to issue appointment order to the petitioner for the post of Chowkidar
 within a period of 15 days after receipt of this order under compliance to this
 court through Additional Registrar. Non-compliance of this order may expose the
 delinquent officers to contempt of court proceedings.
