MUHAMMAD SALEEM JESSAR, J: Learned counsel for the petitioner files minutes of the 36th board meeting of respondent No.1 Pakistan Sports Board under cover of his statement dated 03.06.2026, taken on record. Learned counsel for respondent Nos.1 to 3 also files comments on behalf of respondent Nos.1 to 3, taken on record.

2. At the very outset, Mr. Mohamed Vawda, learned counsel for respondent No.6 proposed that if the matter regarding the affiliation of the petitioner Pakistan Padel Federation may be referred back to respondent No.1 Pakistan Sports Board for deciding afresh after affording opportunity of hearing to all concerned, he will have no objection. M/s. Muhammad Haseeb Jamali and Muhammad Najeeb Jamali, learned counsel for the petitioner accepted such proposal, however, they asserted that till the fresh decision, the operation of the impugned provisional affiliation granted in 36th meeting of the Pakistan Sports Board may be suspended to which learned counsel for Pakistan Sports Board raised no objection.

3. Accordingly, by consent of the parties, petition bearing No. D-2270 of 2026 stands disposed of and the matter for affiliation of Pakistan Padel

Federation is referred back to the Pakistan Sports Board. The affiliation of the petitioner Pakistan Padel Federation and respondent No.6 Pakistan Sports Board shall be decided afresh after affording them an opportunity of hearing. Till the fresh decision on the affiliation, the impugned notification dated 02.04.2026 shall remain suspended. Respondent No.1 Pakistan Sports Board shall complete its proceedings and decide the matter afresh within a period of twenty (20) days' time from today.

4. In view of the order passed in C.P. No. D-2270 of 2026, petitions bearing Nos. 2076 of 2026 and 5867 of 2025 have become infructuous and are accordingly disposed of along with the pending applications.

5. Office is directed to send a copy of this order to respondent No.1 Pakistan Sports Board for compliance. Office also to place a copy of this order in petitions bearing Nos. 2076 of 2026 and 5867 of 2025.
