Learned counsel for the petitioners files incident report at Village Muhammad Siddique Arain, Deh Mirpur Tapa Mirpur, Taluka Thul dated 13.05.2026 under cover of his statement dated 02.06.2010, taken on record. Mr. Zahid H. Rajpar, Advocate files his vakalatnama on behalf of respondent Nos. 12 to 17, taken on record. He also files set of documents including the School Leaving Certificate of petitioner No.1 under cover of his statement dated 02.06.2026, taken on record. The SHO PS Sachal, SHO PS Mirpur Buriro and SSP Jacobabad files reports/statements taken on record. The I.O. of Crime No.24/2026 PS Mirpur Buriro shall remain present along with complete police papers on the next date of hearing. The SSP Jacobabad is also required to be present before the Court along with compliance report. A copy of this order shall be sent by fax to the DIGP Jacobabad for correspondence and compliance. In case of failure, the DIGP Jacobabd shall remain present before the Court. To come up on **04.06.2026** to be taken up at 10:00 a.m.

Learned counsel for the petitioners submits that petitioner No.1 being sui juris, without any coercion or force had contracted marriage with the petitioner No.2 and now she is performing her marital obligations and living with petitioner No.2 with her consent. Learned counsel further submits that respondent Nos.12 to 18, being antagonized upon marriage of petitioners, is causing threats to both the petitioners hence they have

approached this Court for necessary protection of life, honour and property.

3. Mr. Faheem Hussain, learned DPG, submits that official respondents are legally bound to provide legal protection to all the citizens including the petitioners without any discrimination. They after going through the record, ensures that official respondents shall conduct themselves strictly in accordance with law and provide legal protection of life, honour and property to the petitioners in the manner that no one shall cause them harassment. The I.O present in Court has recorded statement of petitioner No.1 in Court and undertakes to submit report in terms of Section 173 Cr.PC. upon the basis of statement of petitioner No.1 recorded by him today in Court.

4. Learned counsel for the petitioners being satisfied with the above statement sought disposal of instant petition with directions to the official respondents to provide necessary protection to the petitioners in the manner that no one shall cause them harassment.

5. In view of whatever discussed above, instant petition stands disposed of with directions to official respondents more to conduct themselves strictly in accordance with law and provide necessary legal protection of life, liberty, honour and property to petitioners in the manner that no one shall cause them harassment. I.O present in Court is directed to submit report in view of the statement of petitioner No.1 before the concerned Magistrate. Office is directed to facsimile the copy of this order to respondents 1 & 7 for compliance. Learned MIT-II to ensure compliance.
