Matter was called in the morning when seeing the facts of the case, respondent No.6 Arbab s/o Gul Sher, who was present in Court alongwith his Counsel, was called upon to produce Mst. Ramsheedan alias Aail Khatoon. In this regard the case file an earlier petition filed by the said lady Mst. Ramsheedan alias Aail Khatoon was also called. Statement of Mst. Ramsheedan alias Aail Khatoon has been recorded in which she has categorically mentioned that she was not kidnapped by respondent No.6 Arbab s/o Gul Sher, who is her husband. She was also given a choice to be sent to Darul Aman for some time so that dispute, if any, can be settled in the intervening period, but she refused to go to Darul Aman and insisted that she should be sent with her husband Arbab s/o Gul Sher (respondent No.6).

Mr. Aslam Baig Laghari the learned Counsel representing private respondents has filed his vakalatnama on behalf of respondents No.6, 8 & 9, and also produced a photocopy of statement of Mst. Ramsheedan alias Aail Khatoon recorded under Section 164 of Cr.P.C before the concerned Magistrate.

At this juncture, Mr. Zainuddin Baloch learned Counsel for petitioner states that still petitioner and his family is facing impending threats from private respondents and police is not providing protection to Petitioner. However, learned A.A.G refutes this claim and submits that police officials, who are impleaded as respondents, are performing their functions in an impartial manner.

Be that as it may, in view of the above submission and peculiar facts of the case, it is ordered that respondents shall not cause any harassment to the petitioner and his family members. Similarly, police officials will provide protection to the petitioner if they are approached with such a request. Police officials are further directed to be dutiful and remain impartial and should discharge their duties in accordance with law by giving equal treatment to every citizen including petitioner and private respondents. With these observations and directions, instant petition stands disposed of.
