ORDER

ADNAN-UL-KARIM MEMON, J. Through the listed application, the petitioners have prayed that contempt of court proceedings may be initiated against the alleged contemnors for willful defiance of the judgment dated 11.10.2018 passed by this Court.

- 2. This petition was disposed of vide judgment dated 11.10.2018 with the following observations:
 - "14. In the light of facts and circumstances of the case discussed above the instant Petition is hereby disposed of with directions to the Competent Authority of the Respondent-department to take a fresh decision so far as the matter of the Petitioners is concerned for regularization of their service, without any discrimination, in accordance with law subject to the budgetary sanction, qualifications, and eligibility of the Petitioners and this exercise shall be completed within two months from the date of receipt of this Judgment.
 - 15. Petition stands disposed of in the above terms along with the listed application(s)."
- 3. We have heard the learned counsel for the parties on the listed application viz. CMA No. 22890 of 2019 and perused the compliance report available on record.
- 4. The compliance report prima-facie suggests that the Scrutiny Committee No.1 found only seven contract employees eligible for regularization and the same were notified vide office order dated 11th March 2020. The reasons

assigned by the committee with regard to 10 petitioners except petitioner No.1 are as under:

The aforesaid compliance report submitted by alleged contemnors has been objected to by the applicants on the ground that the case of petitioners was considered vide summary dated 28.11.2018 and the same was approved for regularization of their services, thus their case ought not to have been reopened by the respondents as a vested right created in their favour; that the stance of respondents has already been rejected by this Court vide order dated 21.01.2020. Accordingly, floating the fresh summary is contradictory to the orders passed by this Court and as such of no legal effect. Learned counsel for the petitioners referred to paragraph 7 of the objections and argued that the cases of petitioners have been wrongly rejected due to lack of academic qualification and work experience. Learned counsel further argued that the Scrutiny Committee is not authorized to reassess the eligibility under Section 3 of the Act 2013. He further pointed out that the exercise conducted pursuant to a fresh summary dated 16.1.2020 is contrary to the order dated 21.1.2020. He prayed for drastic action against alleged contemnors.

- 6. Primarily substantial compliance of the judgment passed by this Court has been made. Prima-facie, the question of not considering some of the petitioners in the regularization process cannot be decided in contempt proceedings, which is a separate cause of action and it is for the aggrieved petitioners to avail their remedy as provided under the law against the purported action on the part of respondents, if any, for the reasons that the respondent-department was directed to take a fresh decision for regularization of their service, without any discrimination, in accordance with law subject to the budgetary sanction, qualifications, and eligibility of the petitioners, which compliance report has now been submitted. Prima-facie the reasons assigned in the aforesaid report cannot be dilated upon for and against in contempt proceedings.
- 7. In view of the above the listed application stands disposed of in the above terms.
