In compliance of last order, Mr. Ghulam Nabi Memon, Additional Inspector General, Karachi has submitted the progress report according to which three accused namely Bilal, Abdul Baqi and Abid have been arrested in Crime No.122 of 2021, whereas one accused Zubair is absconder. He submits that identification parade will be conducted within two days. Similar report has also been submitted by Ms. Shehla Qureshi, Superintendent of Police (Investigation),

District Central in which it is stated that after arrest of accused, the I.O. has taken permission for identification parade which will be conducted today. She further stated that accused are being investigated thoroughly in order to extract more facts and recovery of weapon used in the offence reported under FIR No.122 of 2021. The grandfather of the deceased Usama Saeed (Intervener) is present and submits that he is satisfied with the investigation being conducted by the police. The I.O. of the Crime No.122 of 2021 of PS Sharifabad is directed to complete the investigation diligently and submit the report in the competent court.

So far as the blockage of roads are concerned, all police officials present in court have given a clear statement that all roads are opened and they have also removed the containers however only one road i.e. Sir Shah Suleman Road is being blocked during PSL matches but this road is also opened for emergency vehicles. The statement is supported by the counsel for the petitioner and other learned counsel.

I.G. Sindh was also directed to convey clear directions to all SHOs of police stations that in case traffic is blocked or traffic is diverted through their territorial limits then they should ensure the deployment of proper police force on any such blocked roads to avoid any untoward incident of mobile snatching or dacoities on roads. The Addl. I.G. submits that this message has been communicated to all SHOs through wireless to ensure the strict vigilance and security and he also undertakes that letters will also be issued by the I.G. Sindh for conveying this directions to all SHOs in the province of Sindh. Counsel for the petitioner and intervener

are satisfied to the compliances made in pursuance of the order. Contempt application is disposed of alongwith listed applications.
