Mr. Khair Muhammad, Representative of learned Official Assignee files Reference No.01 of 2021, which is taken on record subject to all just exceptions and objections, if any. Learned AAG submits that the learned Advocate General, Sindh is out of country, who will proceed with the matter on the given date.

It appears that order of this Court dated 13.10.2021 has been impugned through HCA No.208 of 2021, where order dated 08.11.2021 has been passed with regard to the handing over possession of the building i.e. Qasr-e-Fatima (previously known as Mohatta Palace).

With regards to the other part of this Court's order dated 13.10.2021, particularly on the last page as to recovery of properties in Schedule "A" (page 79) counsel states that admittedly none of those assets have surfaced and as per his knowledge some valuable assets have been found in possession of certain individuals. Let a statement be filed in this regard giving names and details of the individuals to whom the inquiries be made in respect of these assets.

With regards un-earthling, locating and taking over possession of above-mentioned debits and securities, Mr. Justice (Retd) Faheem Ahmed Siddiqui is appointed as Commissioner under order XXVI with powers of rule 16 thereof read with applicable provisions of Schedule-I, Appendix D-17 [re: order XX rule 13] to take all necessary steps to find

out whereabouts of these debits/securities; to conduct inquiries in respect thereof; to order for handing out of all sums of money, scripts and all other assets, which shall be found to have come to the hands of any individual, or for their use; to receive all out-standings. Let Justice (Retd) Siddiqui be joined by any likeminded individuals (as per his discretion) to assist him:-

- (8) 3050 shares of Sui Gas Transmission company of the face value of Rs. 100.00 Rs. 143.00 each, Rs. 4,36,150.00
- (9) 31680 shares of Adamjee Industries Limited of the market value of Rs. 15.80 each. Rs. 4,77,735.00
