## ORDER

**ADNAN-UL-KARIM MEMON,** *J*:- We intend to dispose of all the captioned petitions by this single order, as in all these petitions, petitioners are seeking quashment of FIRs, registered against them at the Police Stations concerned under different sections.

- 2. At the very outset, it is stated by learned Additional A.G as well as Investigation Officer(s) concerned, present, that the cases have already been challaned before the competent Court of law.
- 3. Keeping in view above, we have directed the learned counsel present to satisfy with regard to maintainability of these petitions, as the cases have already been challaned before the competent Courts of law and the cognizance thereof have also been taken by the concerned Court(s). However, no satisfactory answer/reply came forward.
- 4. It is well settled law that FIR is nothing but just an "information", the quashment of which will serve no purpose when the cases have already been challaned before the competent Courts of law and cognizance whereof have already been taken by the Courts concerned, therefore, petitioners/accused have the remedy before the

trial Court(s) concerned under Section 249-A & 265-K Cr. P.C, as the case may be, if they deem themselves innocent and intend to avoid lengthy trial.

5. In view of above this Court, under its constitutional jurisdiction, cannot interfere in a settled proposition of law. Accordingly, all the captioned petitions are dismissed being not maintainable; however, petitioners/accused persons are at liberty to avail the remedy before the competent Court of law, as discussed supra, if they so desire. Reliance in this regard is placed on the case DIRECTOR GENERAL ANTI-CORRUPTION ESTABLISHMENT LAHORE & others vs. MUHAMMAD AKRAM KHAN and others (*PLD 2013 SC 401*).
