## <u>ORDER</u>

Muhammad Junaid Ghaffar, J;- After arguing the matter at length, the Petitioners' Counsel have consented to the suggestion of the learned Counsel appearing for Respondent University. Accordingly, both these Petitions are disposed of by consent in the following terms;-

- (i) The Petitioners herein shall approach the Respondent / University with all necessary / requisite documents, through which they can establish that they have been affected by the disaffiliation of their Law College(s) and are entitled / protected to pursue their ongoing LL.B program till completion in terms of Para 20 and the cut-off date as mentioned in the judgment of the Honourable Supreme Court reported as 2018 SCMR 1891 (Pakistan Bar Council vs. Federal Government, through Establishment Division);
- (ii) Once the Petitioners approach with all such documents, the Respondent / University shall examine the same and decide that as to whether the Petitioners are protected in terms of the directions

of the Honourable Supreme Court as above, and if so, then, can they be accommodated in some affiliated College(s) enabling them to complete the courses for which they were already admitted before de-affiliation of their Colleges;

- (iii) The above arrangement is by consent and after the University finally decides the cases of the petitioners, as agreed, there would be no further challenge to the said decision;
- (iv) The above arrangement shall not be treated as a binding precedent for any other purposes;
- 2. With these observations, the Petitions are disposed of in the above terms. Office to place copy of this order in the connected petition.
