This a bunch of four Constitutional Petitions, filed by the petitioners with regard to same reference and the impugned judgment. However, since Constitution Petition No.D-2302 of 2019 has been filed by petitioner Allah Bachayo Jatoi for pre-arrest bail; whereas, the other matters are with regard to post-arrest bail in the same subject reference being No.02 of 2018, therefore, the petition bearing No.D-2302 of 2019 is hereby de-tagged from the other petitions. Let it be fixed separately on 27.05.2021. At this juncture, Ms. Razia Ali Zaman Patoli Advocate has appeared and submits that C.P. No.D-1472/2020 and Cr. Acquittal Appeal No.D-04/2020, which have also been filed in respect of the same subject reference as well as the impugned judgment, are not fixed alongwith the present petitions. She requests that both the aforementioned petition as well as the appeal may be connected and fixed alongwith C.P. No.D- 2302 of 2019 on the next date of hearing. Order accordingly.

As regards, the petitions being Nos.D-1183/2018, 2716/2019 and 154/2020 are concerned, learned Special Prosecutor for NAB submits that

these petitions may be disposed of in the same way as of other matters wherein this Court disposed of those petitions with direction to the trial Court to hear the cases preferably on day-to-day basis, which order has been complied with and the matters are being proceeded swiftly.
