At very outset learned Counsel for the Respondent No.1 referred the letter

dated 13.05.2020 available at page-43 of this file, which reads as under:-

REQUEST FOR ISSUING DETAIL STATEMENT DECEASED SYED MEHTAB ALI S/O SYED HABIB ALI REGARDING THIS BENEVILENT FUND, GP FUND & OTHERS etc.

Referred to the enclosed letter of Mr. Gulsher Baloch Advocate High Court Sindh, Karachi No.235/19 dated 30.08.2019, on the subject above.

Accordingly as per rule/policy the final Dues of deceased legitimate "Survive Families" verified statement enclosed by herewith Finance Deptt, KW&SB details as under:-

- I. The AO (Pension) calculated pension Gratuity Amounting Rs.10,51314, and airier of family pension from 12.10.2017 to 29.02.2020, amounting 7,34,131, and the Financial Assistance as per policy scheme schedule as the deceased was in (BS-14) amounting 12,00000 the share of pension distribution and arrears of family pension as per rule/policy.
- II. The (AO) Establishment calculated Lump sum payment of Rupees 340,920/-, full pay upto (365) days out of his leave account to the deceased families for the purpose of family pension as per rule (Statement copy enclosed).
- III. In Partial Modification of the Office Memorandum No.KW&SB/HRD&A/LWO/CBA/2018/165/L dated 21.02.2018 the clause 27 item 19 of the agreement of CBA the uneral charges increase Rs.15,000/- instead of Rs.20,000/- vide corrigendum No.KW&SB/HRD&A/LWO/2018/275/L dated 02.07.2018 (copy enclosed).
- IV. The AO (Fund) calculated the Final balance upto October 2017 amounting to Rs.6,52,821/- as per statement generated by (I.T) department (Statement Copy enclosed).

You are requested to please convey to the Advocate High Court, Mr. Gulsher Baloch to proceed issuance of succession certificate from Court of Law, for deceased legal heirs enable as per opinion of law department KW&SB for further necessary action under rule."

Learned counsel for the Respondent No.1 submits that once the Petitioner submits the Succession Certificate issued by the competent forum, the amount and other benefits mentioned in the aforesaid letter will be released to the Petitioner without any further delay.

In wake of above statement, counsel for the Petitioner being satisfied seeks disposal of this petition. Order accordingly.
