Mr. Qurban Ali Malano, Advocate has filed Vakalatnama on behalf of private Respondents No.15 &16, which is taken on record. he requests for time to assist the Court. Time granted.

It appears that on 22.03.2022 after examining rival contentions of Petitioners' Counsel as well as learned AAG and private Respondents' Counsel, we had passed the following order:

"It appears that in this matter, the petitioners' grievance is that on the behest of private Respondents, the official Respondents including police authorities and concerned Deputy Commissioner/Assistant Commissioner are creating hindrance in lawful business of Cattle Piri for which Petitioners possess valid license till 30.06.2022. Though comments have been filed on behalf of SSP; however we are not satisfied with the comments as various photographs with the petition are annexed, which reflect that police is interfering in the lawful business of the petitioners. Moreover, comments of Deputy Commissioner are yet to be filed. Learned AAG is directed to file appropriate comments from both Respondents i.e. SSP and DC Naushehro Feroze and in categorical terms as to allegation of petitioners positively on the next date.

Adjourned to **07.04.2022**; to be taken up at 11:00 a.m."

Subsequently, on 07.04.2022, the following order was passed:

"Today, comments have been filed on behalf of Respondents No.4,6,9&10; which are taken on record and copies whereof have been supplied to the Petitioners' Counsel, who needs time to go through the same.

As to the resolution of dispute amongst the Petitioners and private Respondents No.15&16 as to conducting Cattle Piris on alternate days, let matter be taken up by themselves and Court be informed on the next date as to any consensus or otherwise.

Adjourned to **10.05.2022** to be taken up at **11:00 a.m.** Interim order passed earlier to continue till the next date".

On 10.05.2022, we were informed that the issue could not be resolved, as directed and today once again matter stands there. The idea behind passing of the above orders was to send the matter to concerned officials as it is their responsibility to maintain the law and order. The dispute has arisen because private respondents have been granted permission to run and manage a *Cattle Piri* on the same day i.e. Saturday, as has already been granted since long to the Petitioners, though purportedly, in a different District; but admittedly, both *Cattle Piris* are almost adjoining and are not at a desired distance, as would be ideal to avoid conflict between the parties, and warranting any interference by the District Administration and area Police of both jurisdictions.

We are still of the considered view that the matter ought to be resolved by the concerned Deputy Commissioners and Market Committees, as it is the responsibility of the District Administration to look into such aspect and maintain law and order as well, but they have failed to resolve the issue. Today, as per request of the learned AAG, we direct the Commissioner, Sukkur to take up this matter and call a meeting of the concerned parties including two Deputy Commissioners, Market Committees and concerned SSP's and try to resolve the issue as to running and managing of *Cattle Piris* on separate days. Let such exercise be carried out and completed within a period of thirty (30) days from today and a report to that effect be filed in Court. Let copy of this order be issued to Commissioner Sukkur, as well as AAG's office.

Adjourned to **30.06.2022**. Interim order passed earlier to continue till the next date.
