As against the objections of the objector / petitioner in relation to proposed delimitation of Town Committee Islamabad Kot district Tharparkar, the following order was passed:-

"Arguments heard, record perused, map has also been perused, at the prima facie, on examination of map of Town Committee Islamkot, District Tharparkar, it has been observed that the request of petitioner does not fu lfill the Principles of Delimitation under Section-20 Election Act, 2017, which is reproduced below:

"20. Principles of delimitation.---(1) All constituencies for general seats shall, as far as practicable, be delimited having regard to the distribution of population in geographically compact areas, physical features, existing boundaries of administrative units, facilities of communication and public convenience and other cognate factors to ensure homogeneity in the creation of constituencies."

Keeping in view the principles of Delimitation, the existing Delimitation cannot be changed, as if the changes are made in accordance with the request of the Petitioner, it will affect the population of criteria and compactness of wards, which is a violation of aforementioned principles of Delimitation. Hence the proposal / objection of the petitioner is rejected. The copy of orders be sent to the Delimitation Committee immediately with the direction to incorporate the decision

accordingly for publication in the final gazette of delimitation District Tharparkar. File after compilation be kept in safe custody.
Decision:
Rejected"
Viz-a-viz objections though the same are not available on record; this seems to be sufficient compliance and no interference is required to the mpugned order. The petition is dismissed.
