At the very outset, Petitioners and their Counsel present in Court today submit that National Accountability (Amendment) Act, 2022 is deemed to have been assented by the President w.e.f. from 22.6.2022 pursuant to Article 75(2) of the Constitution of Islamic Republic of Pakistan and has a Gazette has also been issued on 22.6.2022 and in terms of newly amended Section 9(b) of the National Accountability Ordinance, 1999, powers to deal with bail matters have been conferred upon the Accountability Court(s) established thereunder. In the circumstances, they request that instant Petitions seeking Pre-arrest Bail be converted into Protective Bail Applications and Petitioners may be allowed to remain on protective bail for ten days with direction to appear before the said Court.
