Aftab Ahmed Gorar, J; Through instant Criminal Transfer Application, the applicant/complainant seeks transfer of Direct Complaint No.79/2014 (Now Sessions Case No.79/2016) Reg: Mohib Ali vs. Allah Wadhayo and others from the file of learned 5<sup>th</sup> Additional Sessions Judge, Sukkur to the Court of learned 3<sup>rd</sup>. Additional Sessions Judge (MCTC) Sukkur, on the ground that the State case arising out of the same incident i.e. Sessions Case No.388/2014 re- St.Vs. Ameen and others is pending trial before the Court of learned 3<sup>rd</sup>. Additional Sessions Judge (MCTC) Sukkur.
