ORDER

YOUSUF ALI SAYEED, J. - The Petitioner professes to be the President of the Anjuman-e-Muhibban-e-Hussaini Ahaliyan-e-Gilgit (the “**Anjuman**”) and has invoked the jurisdiction of this Court under Article 199 of the Constitution, impugning a letter dated 02.12.2021, bearing Reference No. PAR/KAR/REGN/1959-60/996/2021/12, addressed by the Provincial Assistant Registrar, Joint Stock Companies, Sindh, Karachi to the legal counsel of the Petitioner in response to his Letter No. Nil dated 29.11.2021 pertaining to the affairs of the Anjuman.

2. Through the Petition, it has been prayed that this Court be pleased:

“A. To set aside the Respondents No.4 and 5, letter dated 02.12.2021, as well as further prejudicial action taken by Respondent No.5, on personal grudges and

- B. To direct the Respondents No.1 to 4, to issue Renewal Certificate to the Petitioner Society namely “Anjuman-e-Muhibban-e-Hussaini Ahaliyan-e-Gilgit” a Registered Society, registered vide Registration No.996, dated 16.01.1960.
 - C. To grant exemption from submission renewal certificate and pleased to extend time for submission online initial and detailed form for registration before Sindh Charity Commission as well as in civil proceedings.
 - D. To suspend the Respondents No.4 and 5, letter dated 02.12.2021, till the disposal of Petition.
 - E. Any other relief or reliefs in the circumstances of the case as this Hon’ble Court deems fit and proper in the circumstances of the case which the Petitioner omitted to pray or otherwise entitle to may also be granted and also reliefs by taking into consideration any subsequent events.”
3. From a perusal of the impugned letter dated 02.12.2021, it transpires that the very registration of the Anjuman has previously been cancelled/rescinded by the Provincial Assistant Registrar, Joint Stock Companies, Sindh, Karachi, with the relevant paragraph of the said letter reading as under:-

“After publication of the above said notices, this office vides Order bearing No.PAR/KAR/REGN/ 2019/06-09 dated 24.12.2019 and PAR/KAR/REGN/ 2019/02-05 dated 26.12.2019 respectively, cancelled rescinded the registrations of the NPOs/NGOs/Societies/Associations/Anjumans etc including the above said Anjuman.”

4. Those orders of cancellation/rescission have not been challenged by the Petitioner, as such we see no force in the instant Petition, which accordingly stands dismissed *in limine* along with pending miscellaneous applications.
