- 4 & 5) Through this Petition filed through an attorney, the Petitioner Mirza Qadir Baig S/O Mirza Yahir Baig seeks protective bail in FIR No. 1145/2021 registered under Section 489-F/PPC at P.S. Aziz Bhatti (East) Karachi. Learned Counsel for the Petitioner in attendance along with the attorney of the Petitioner, submits that the above FIR has been registered by a close relative of the Petitioner, falsely implicating the Petitioners, whereas, presently, the Petitioner is out of country; but intends to come to Pakistan and surrender before the concerned trial Court to obtain bail. According to him, it is apprehended that upon his arrival he may be arrested in the above crime. He submits that the scheduled flight for return of the Petitioner is on 30.12.2021 and in support he has referred to Page 21 which is an electronic ticket issued by the concerned Airline. While confronted as to grant of this extraordinary relief in absence of the Petitioner, learned Counsel has relied upon cases reported as ***Sharjeel Inam V. Federation of Pakistan and others (2017 Y L R 2423)***, ***Mst. Khalida and another V. Province of***

***Sindh through Home Secretary and 3 others* (2014 MLD 1443),  
*Ghulam Asghar and 3 others V. The State* (2010 P.Cr.L.J. 1474)  
and *Javed Iqbal Mirza V. National Accountability Bureau* (2007  
P.Cr.L.J. 1230).**

In view of the above, and without touching merits of the case, the Petitioner is admitted to protective bail for a period of 10 days from today enabling him to come to Pakistan and surrender before the concerned trial Court for obtaining interim pre-arrest bail in the sum of Rs. 50,000/- to be furnished before the Nazir of this Court to his satisfaction. This order shall remain valid for a period of 10 days from today or when the Petitioner surrender before the trial Court, whereas, the Petitioner shall not be arrested on his arrival at the Airport.

With these observations, the Petition stands disposed of.
