Publication of the main petition has been effected in daily "Jang", daily "Express" and daily "Kawish" dated 22.12.2015 but none has come forward to file any objection from any corner. The witnesses namely Dr. Aly Khan son of Israr Muhammad (CNIC No. 42201-9142965-7) and Brig. (R) Ahmad Shamshad (CNIC No.42000-0507694-1 have sworn their affidavits stating therein that the deceased has left the aforesaid legal heirs and no other person is the legal heir of the deceased Umar Jan except the persons mentioned above.

A Family Registration Certificate issued by NADRA is also attached with the petition showing the aforesaid widow, son and daughters to be the legal heirs of the deceased person.

As, all the necessary legal requirements have been fulfilled, therefore, there appears to be no impediment left for the grant of this petition. The petition is accordingly granted. Let the Letters of Administration and Succession Certificate be issued in accordance with the rules. Needless to mention that Letter of Administration would be for the purpose of change of title of the subject matter property in favour of the legal heirs and distributing moveable assets among the legal heirs under authenticated receipt. Be that as it may custodian of the record of rights are required to act strictly in accordance with law. In case, title of subject matter is under clouds in any manner or under adjudication of any Court of law, they shall not be influenced by the order of this Court.
