Deceased Zohra Shafiq has left behind the legal heirs namely, (1) Asad Shafiq Bari (son), (2) Azra Manzoor (daughter), (3) Javed Shafiq (son). Legal heir No.1 Asad Shafiq Bari is petitioner in the instant petition and son of the deceased. Legal heirs Nos. 2 &3 are

present today. Legal heirs No.2 and 3 are present. Legal heir No.2 has filed her affidavit of no objection in favour of the petitioner whereas legal heir No.3 Javed Shafiq also filed affidavit of no objection in favour of the petitioner, duly attested by Civil Judge and Judicial Magistrate 1st Class, Lahore. Two witnesses, namely, Siddig Ahmed Meher and Hamid Sultan Elahi have filed their affidavits that they knew the parties. Learned counsel for the petitioner submitts that both above named witnesses have proceeded to perform Haj. Now affidavit of two witnesses, namely Masood Ashfaq and Mustaq Ahmed Allahwala have been filed. Both are present in court and stated that deceased left behind the above named legal heirs. Publication of main petition has also been effected in daily express Karachi dated 01.06.2015 but none has filed any objection from any corner. Admit. Since legal heirs present have recorded no objection in favour of the petitioner. Counsel for the petitioner is directed to produce the original documents of the properties mentioned above on the next date of hearing. Adjourned to a date in office. Legal heirs as well as witnesses present need not to attend".

As per report of Assistant Registrar Execution & Misc. Branch, compliance of the order dated 21.10.2015 has been made. Since all formalities have been completed, hence petition is allowed. Office is directed to issue Succession Certificate in favour of the petitioner subject to rules.
