4&5) Mr. Imran Taj holding brief for Mr. Kh. Shamsul Islam requests that the latter's name be deleted as being counsel engaged by alleged contemnors. Since Mr. Khalid Jawed Khan has been engaged by alleged contemnors, though he has filed Vakalatnama on behalf of petitioner, the oral request is allowed and name of Mr. Kh. Shamsul Islam is deleted from the file and his Vakalatnama is discharged. In pursuance of pending references and application, if any, Vakalatnama filed by Mr. Khalid Jawed Khan in Court today is taken on record.

Before the disposal of JM No.29 of 2020 some interim arrangements were made in the shape of orders dated 15.12.2020, 19.04.2021, and 14.12.2021. To my understanding the interim arrangement was in respect of payment of salaries to the employees of Isra University and other routine expenses incurred on daily and monthly basis. It is Mr. Almani's case that since now new Chancellor is appointed therefore in all fairness the Chancellor be allowed to submit a list of employees and expenditure of the university.

Perhaps the Act would define role of Chancellor and Vice Chancellor and before reaching to such conclusion I am of the view that all such affairs, as ordered as interim measure, referred above, shall continue and Nazir shall continue to disburse salaries of employees of Isra University accordingly in terms of list already available with him (Nazir) including payment towards utilities and/or any other lawful routine expenses likely to be incurred. In case any additional employees were made/appointed by the Chancellor within his role provided under the Act and/or by Vice Chancellor within the frame of the Act that may, in the form of a reference be submitted for consideration. Nazir shall prepare such list of such employees and the basis on which payments are being made to individual employees and so also other expenses, referred above, so that appropriate orders be passed, in case any ghost employees are being paid, which require scrutinization. Till such final conclusion as to the payment of salaries and expenditures, this interim arrangement shall continue unless otherwise ordered. Admittedly these cases and/or arrangement pertain to the Hyderabad Campus of Isra University and the hospital attached therewith. Tentatively Nazir may also draw fee of Rs.50,000/- for such assignment one time only.
