ORDER

MUHAMMAD IQBAL KALHORO, J- Applicant and co-accused allegedly assaulted on complainant over some dispute on sale of a car and inflicted three injuries on his person near Railway Mori, Jamshoro on 15.11.2021 at 04:45 p.m. and took his car. Out of them one injury 337-A(ii) PPC is non-bailable, punishable upto five years, whereas the remaining two injuries 337-A(i) PPC are bailable. But none of them is attributed to applicant. It is informed that entire case has proceeded except I.O who is likely to be examined on the next date of hearing i.e. 09.09.2022. In view of the ratio laid down by the Hon'ble Supreme Court in the case of REHMATULLAH v. The STATE (2011 SCMR 1332) that when the case has been reached advance stage, the ad-interim pre-arrest bail granted to the accused cannot be recalled and it shall be left to the trial Court to decide the case through full and final judgment which in this case is likely to be announced in a period of one month.

2. In view of such situation and no specific role of applicant, with the consent of the parties, these applications are allowed and the ad-interim pre-arrest bail of the applicants is hereby confirmed with direction to the learned trial Court to examine the I.O on the next date of hearing without fail and announce the judgment within a period of one month thereof. No party shall be allowed adjournment on any ground.

3. With the above observations, the applications are disposed of accordingly.

I have heard the parties at some length.
