placed on record copy of Nikahnama as well as copy of Cr.Misc.A.  
No.1092/2012 and order passed thereon which reflects that  
Mst. Afshan and respondent No.9 are wife and husband inter se.

Mst. Afshan bibi is produced in Court. She is sui juris.  
She states that neither she has been abducted nor enticed away. In  
fact she left her parents' house about nine months back and  
ultimately contracted marriage with Asad s/o Abdullah Chachar  
(respondent No.9). She further states that she is living happily with  
her husband Asad and is pregnant. Neither she has been kept in  
wrongful confinement nor her movements have been curtailed. She  
desires to go with her husband Asad.

In view of above, she is set at liberty to go with her  
husband Asad. Inspector Zaheeruddin Babar, SHO, PS, B-Section,  
Ghotki, is directed to provide protection to the petitioner and her  
husband and ensure that no harm is caused to the couple. Besides,  
no FIR shall be registered in respect of abduction or kidnapping of  
alleged detainee Mst. Afshan bibi as she has categorically stated  
that she is legally wedded wife of Asad.

Petition stands disposed of.
