Notices were issued to the respondents as well as A.G Sindh with direction to the I.G. Police Sindh to ensure compliance of the orders passed by this Court in C.P.No.D-8436/2017 dated 11.12.2017, C.P.No.D-868/2019 dated 30.09.2019 and C.P.No. S-349/2023 dated 12.04.2023 by directing all concerned SSPs.

Today official respondents have filed their respective reports, which are taken on record. AIGP/ Legal-II is present, has also filed report on behalf of I.G Police Sindh, wherein details of the raids conducted by Provincial Task Force w.e.f. 28.03.2023 to 19.07.2023, have been shown, which reads as under:-
