1. Through this petition, the Petitioner challenges the actions of the Respondent 3 & 4 restricting parking of its vehicles in front of university's building during the Pakistan Super League ("PSL") matches in national stadium Karachi. The Petitioner files this petition through its duly authorized representative, Mr. Danish.

Through instant petition filed by Indus University which according to learned counsel for the Petitioner, is situated in the close vicinity of the National Stadium and facing similar inconvenience as expressed in C.P. No.D-334 of 2024 [M/s. Shazz Super Market versus Province of Sindh and others] and submits that keeping in view the Order passed in C.P. No.D-334 of 2024, today on the contempt application, instant Petition may also be disposed of in similar terms with directions to the Respondents that they may not cause any unnecessary hindrance or inconvenience to the faculty, Members, students of the University and allow them to park their vehicles in front of University during PSL matches.

Learned AAG present in Court waives notice of instant Petition, claims its copy, however, does not oppose disposal of the instant Petition in terms of order passed in C.P. No.D-334/2024 today, however, submits that request of the Petitioner in the above Petition to allow the car parking on

the roads just behind the National Stadium may not be acceded in the interest of Petitioner, as according to learned AAG matter may be left to the administration / Traffic authorities who may be directed to act in accordance with the law, as according to learned AAG, parking on the streets / road otherwise has to be regulated as per law.

Accordingly instant Petition stands *disposed of* in terms of the order passed today in C.P. No.D-334 of 2024, *whereas*, request of the Petitioner with regard to allowing the parking to the faculty members/students in front of petitioner's University may be considered by the concerned District Administration / Traffic Police in accordance with the law.
