The Statement of the Secretary is a cause of concern and shows the bad governance prevalent in the Government Department. The Chief Secretary should take immediate notice to this fact.

Consequently, the Worthy Chief Secretary (Sindh) is directed to immediately hold an Inquiry, fixing the responsibility, take action and submit a Report within two weeks about the above Statement of Dr. Badar Jamil Mendhro.

To be listed on **25.04.2024** at **11:00 a.m.** On that date, Dr. Badar Jamil Mendhro, Ex-Secretary Cooperative Society Department, should be present along with Mr. Muhammad Murad, Section Officer, Cooperative Society Department.
