It is *inter alia* contended that police has registered the FIR against all applicants for malafide reasons and the applicants / accused are prepared to surrender before the trial court but apprehend their arrest with ulterior motive.

Without touching the merits of the case and in order to enable the applicants to approach the concerned Court for pre-arrest bail, protective bail for the period of five (05) days from today is granted to the applicants / accused subject to their furnishing solvent surety in the sum of Rs.30,000/- (Rupees thirty thousand) each and P.R Bonds in the like amount to the satisfaction of Additional Registrar of this Court. The applicants / accused are directed to surrender before the trial Court within aforesaid period.

This order shall cease to have its` effect on expiry of five (05) days from today i.e. on 13.02.2022 or on the applicants` surrendering themselves before the concerned Court, whichever is earlier. In case applicants / accused failed to

surrender before the trial Court within aforesaid period, their bail bonds shall stand automatically forfeited.

The bail application stands disposed of in above terms.
