Appellant Shafique was tried by Special Judge for CNS, Sanghar in Crime No.63/2010 of P.S Shahdadpur for offence under Section 9(b) Control of Narcotic Substances Act, 1997. By judgment dated 14.07.2010 appellant was convicted under Section 9(b) Control of Narcotic Substances Act, 1997 and sentenced to 02 years R.I and to pay a fine of Rs.10,000/-, in case of default in payment of fine, he was ordered to suffer S.I for 02 months more. Appellant was expended benefit of Section 382(B) Cr.P.C

Jail Roll of appellant is received today from the Superintendent District Prison, Sanghar, in which it is mentioned that appellant was convicted on 14.07.2010 and was released from prison on 02.04.2011 after getting total remission earned 334 days and fine of Rs.10,000/- was paid by appellant/accused on 26.03.2011. It appears that several notices have been issued to the appellant/accused but he never appeared to pursue/contest the appeal. It is reported by SHO P.S Shahdadpur that appellant has shifted to some unknown place.

In the view of above, there is no justification to keep this appeal pending more. Learned D.P.G has assisted the Court and read out the prosecution evidence. The impugned judgment dated 14.07.2010 suffers from no infirmity, the same is maintained. Since the appellant did not appear to contest it and he has been released, appeal is accordingly disposed of.
