Appellant Muhammad Usman was tried by learned Sessions Judge/Special Judge (CNS) Mirpurkhas in Special Case No.20 of 2008. By judgment dated 01.06.2009, the appellant was convicted under Section 9(c) Control of Narcotic Substances Act, 1997 and sentenced to 02 years R.I with payment of fine of Rs.5000/-, in case of default in payment of fine, the appellant was ordered to suffer S.I for 03 months more. Benefit of Section 382(B) Cr.P.C was extended to him.

Appellant preferred the instant appeal against his conviction and sentence recorded by the Trial Court. During the pendency of the appeal, Jail Roll was called. Superintendent Central Prison, Hyderabad vide his letter dated 21.04.2015 has reported that convict/appellant has already been released from the prison on 21.11.2009 on the completion of his sentence by getting 240 days remission. Notice was issued to the appellant to ascertain whether he is still contesting the appeal or not. Appellant present in Court submits that he has already completed his sentence, therefore, he does not want to contest the appeal.

We have perused the evidence and the impugned judgment and assistance of learned D.P.G and came to the conclusion that the Trial Court on the basis of sufficient and huge evidence had convicted the appellant and

sentenced him as stated above, therefore, the impugned judgment requires no interference. Since the appellant Muhammad Usman has been released from the jail on the completion of the sentence, the appeal has become infructuous. Appellant is no more interested to proceed with the appeal and since the appeal has become infructuous, it is accordingly disposed of.
