Through instant constitutional petition, the petitioners have prayed for the following relief (s):-

- (a) To direct the respondents to release the salaries of the petitioners for the post of Chowkidar/Naib Qasid BPS-02 since October, 2012 with immediate effect and pay their future salaries regularly without fail.
- (b) To restrain the respondents from cancelling the appointment orders of the petitioners and from filing the vacancies of petitioners and to accommodate the persons of their own choice, during pendency of the petition.

Notices were issued to the respondents. Comments are filed by the respondent No.1.

Today, Azizullah Odho D.E.O Jacobabad, is present in Court and states that as soon as petitioners submitted the documents, the case for their appointment shall be submitted to the competent authority. D.E.O, further submits that following formalities are to be fulfilled by the petitioners.

- (i) Copy of agreement bond signed by the applicant/plot donor and DOE concerned regarding construction of school building.
  - (ii) Copy of Form VII-A/ B duly signed by the Mukhtiarkar concerned showing ownership of plot/ land of the applicant/donor.
  - (iii) NOC of other shareholders of land/plot and other heirs of property.
  - (iv) Present status of school.
  - (v) Qualification/Domicile/PRC of the applicant.

- (vi) Certificate from relevant officer that land donated for construction of school stand transferred in the name of Education & Literacy Department, Government of Sindh.
