This Court vide order dated 17.02.2016 disposed of this petition (C.P.No.D-352 of 2013) in the following terms:-

“Learned Counsel holding brief for the counsel for the Petitioners states that the official respondents may be directed to strictly act in accordance with law. Learned Addl. A.G. has filed compliance report of SSP, Shaheed Benazirabad in compliance of order dated 19.08.2015, which is taken on record. He states that official respondents would strictly act in accordance with law. In the above terms, this petition is disposed of.”

Mr. Ahsan Gul Dahri, Counsel for petitioners in disposed of C.P.No.D-352 of 2013 contended that after the disposal of his petition some persons of the Zardari community have committed five murders of the petitioners’ side and FIR has been lodged regarding that incident but Investigation Officer has failed to conduct fair investigation in the case. Mr. Dahri submits that further investigation may be transferred to some honest police officer. Learned Additional A.G submitted that C.P.No.D-352 of 2013 has already been disposed of.

In the view of above, it is observed that Mr. Dahri, Counsel for petitioners in disposed of petition would be at liberty to file fresh constitution petition for the relief for which submission is made, then the same shall be dealt with in accordance with law.

Learned Counsel for petitioners in C.P.No.D-1913 of 2021 by way of his statement filed some documents alongwith photographs, which are taken on record. Let the copy be supplied to the other side. Mr. Dahri submitted that SSP Shaheed Benazirabad has failed to provide protection to the petitioners, resultantly five murders were committed. It is observed that it is the duty of the State to provide protection to every citizen including the petitioners.

In the view of above, DIGP Hyderabad is directed to provide protection to the petitioners in accordance with law and submit the compliance report before this Court on 24.03.2022. Let the copy of the order be sent to the DIGP Hyderabad by fax for strict compliance.
